eHealth Award 2020

Terms and Condition for Participation

- 1. The competition for eHealth Award 2020 is organized by Vitalis (Mässans Gata/Korsvägen, 412 94 Gothenburg), Sahlgrenska Science Park (Medicinaregatan 8 A, 413 46 Gothenburg), Cerner Sverige AB (Vasagatan 12, 111 20 Stockholm) and HealthTech Nordic (Scheeletorget 1, 223 81 Lund).
- 2. The competition for eHealth Award is open to Nordic (Swedish, Danish, Finnish, Norwegian, Icelandic) small businesses that have developed an innovative product or solution for eHealth and meet the participation criteria. A small business entitled to participate will be considered any Nordic legal entity or sole trader that employs more than one and less than 20 employees ("Eligible Businesses").
- 3. The Eligible Businesses wishing to participate shall have developed an innovative product or solution for eHealth that meets the following criteria:
- a. The product or solution has been piloted and tested and has shown beneficial results for patient, citizen, clinician, and/or healthcare organization;
- b. The product or solution must have the potential for scalability on a national and international level
- c. To an extent or fully have involved the end user group as part of the development of the product/solution
- d. The product/solution must to a degree improve or affect one or more of the following:
 - i. Enhance citizen and/or patient engagement;
 - ii. Enhance work processes for health care and welfare professionals;
 - iii. Organizational development:
 - iv. Care outcomes;
 - v. Improved quality of life

The Eligible Business may participate with several different products or solutions if they meet the criteria above.

- 4. All information detailing how to enter this competition forms part of these terms and conditions. It is a condition of entry into the competition that the Eligible Business agrees to abide by these terms and conditions. Submission of a registration form shall indicate the acceptance of these terms and conditions by the Eligible Business.
- 5. Entries into the competition should be submitted by filling in a registration form and submitting it through the designated website. All registrations for the competitions must be received by the registration closing time and date, which has been announced on the designated website. The jury may at their discretion extend the deadline for entries. Late, illegible or incomplete entries will not be accepted.
- 6. The jury may request the participating Eligible Businesses to provide further information on the Eligible Business or their product or solution in the course of the competition. Participating Eligible Businesses are responsible for ensuring that all information provided in the registration form and in the course of the competition process is accurate and complete. Should the jury find that any

information provided to it is in breach of these terms and conditions, it may exclude the Eligible Business from the competition.

- 7. No fee will be charged from the Eligible Businesses for participating in the competition. The organisers will not cover any costs or expenses incurred by the participating Eligible Businesses due to their participation in the competition and the Eligible Businesses shall at all times remain be liable for any costs incurred.
- 8. The jury of the competition will consist of representatives of the organisers and the healthcare and welfare sector. The jury will select the winner of the eHealth Award based on which product or solution entered into the competition is most innovative in terms of improving one or all of the following:
 - i. Enhance citizen and/or patient engagement;
 - ii. Enhance work processes for health care and welfare professionals;
 - iii. Organizational development;
 - iv. Care outcomes;
 - v. Improved quality of life

In addition, the jury will select the first and second runner up from the competitors' products or solutions based on the same criteria.

- 9. The jury's decision is final and cannot be appealed.
- 10. The three finalists will be notified after the final jury meeting. The competitors shall keep this information confidential until the public announcement of the winner at Vitalis on 5 May 2020.
- 11. The winner of eHealth Award 2020 will be provided with the prize of SEK 50 000, and 10 hours publicity work provided by Miltton Group. The prizes are non-transferable. The winner shall be responsible for payment of any taxes due on the prizes.
- 12. The winner will be invited to participate in a relevant arena, such as Cerner's European Collaboration Forum in London 2021 (at Cerner Sverige AB's discretion).
- 13. The participating Eligible Business retains all intellectual property rights in the product or solution named in its entry for the competition for eHealth Award. The participating Eligible Business warrants that by participating in the competition with the product or solution named in the entry for the competition the Eligible Business does not infringe any third party's intellectual property rights. The Eligible Business agrees to indemnify the organisers against any damages, including reasonable legal fees, arising out of a claim that the participation of the Eligible Business in the competition infringes third party's intellectual property rights.
- 14. The organisers may use the three finalists' name, tradename, logos, trademarks or product/solution names in connection with advertising, press releases or otherwise regarding the future eHealth Awards and in the organisers' marketing regarding their contribution to the eHealth Award.
- 15. The organisers of the competition reserve the right not to award the prize or to cancel or modify the eHealth Award competition with no liability to the participating Eligible Businesses in the following events:
